Policy on Anti-Ragging

In pursuant to the judgment of the Honorable Supreme Court dated 08-05-2009 in Civil Appeal No. 887/2009, and to prohibit, prevent and eliminate the scourge of ragging in Educational institutes, the University Grant Commission (UGC) has bring forth appropriate "Regulation on curbing the menace of Ragging in Higher Education Institutions, 2009". Keeping these directives and guidelines into consideration, Govt. Degree College Uri has adopted a Zero Tolerance Policy towards Anti Sexual harassment and Ragging. Ragging is a criminal offence and it is a violation of human rights.

Ragging, as defined by the Honble Supreme Court of India in its landmark judgment in 2001, is "Any disorderly conduct weather by words spoken or written or by in act which has the effect of teasing, treating or handling with rudeness any other student, including in rowdy are undisciplined activities which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in a fresher or a junior student or asking the students to do any act or perform something which such student will not in the ordinary course add which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student".

As per the Clause -3, UGC Regulation 2009

Raging is "Any act of physical or mental abuse (including bullying and exclusion) targeted at another student (fresher or otherwise) on the ground of colour, race, religion, caste, ethnicity, gender (including transgender), sexual orientation, appearance, nationality, regional origins, linguistic identity, place of birth, place of residence or economic background now amounts of raging."

The Govt. Degree College Uri is committed itself to provide a congenial, conductive and peaceful atmosphere in which students, teachers and non teaching staff can work together in an environment free of violence harassment, exploitation and intimidation.

Objectives of the Anti Ragging Policy:

- To implement the directives and guidelines issued by the Honble Supreme Court and UGC regarding in the institution.
- 2. To investigate, deliberate and take necessary measures with regard to cases of raging and other untoward incidences that may take place in the institution.
- To administer appropriate disciplinary measures when a violation is found to have occurred as provided by this policy.
- 4. To prevent the occurrence of raging cases in the institution.
- 5. To conduct workshop or awareness programme to curb the ragging menace and orient the students.
- 6. To create a secure, candid and conducive physical and social environment this will deter acts of raging.
- 7. To institutionalize Ragging policy in the institution in letter and spirit.



Role and responsibility of Anti-Ragging Committee

- 1. To ensure safe and conducive educational environment that is free from ragging and other related issues.
- 2. To conduct regular awareness programme and other services of counseling for all the students on ragging issues in order to acquaint them about the gravity of the offence and consequences
- 3. To display anti-sexual harassment/ragging posters on notice boards in common areas within the campus.
- 4. To treat ragging as a severe misconduct and initiate punitive actions for such misconduct.
- 5. To assist the aggrieved student to place the complaint.
- 6. To safeguard the one who is victimized.
- 7. To take all necessary measures for prevention of ragging inside the campus/hostel.

Remedial Steps

- 1. To ensure that the mechanism for registering complaints is safe and accessible.
- 2. To take cognizance of complaints about ragging, conduct enquiries, provide assistance and redressal to the victims.
- 3. To recommend fines penalties and punishment.
- 4. To seek medical, police and legal intervention with the consent of the complainant if found necessary.

Procedure for filing a complaint and redressal mechanism thereof:

- 1. An aggrieved student may submit an online application seeking redressal of grievance through the online Grievance portal of the college or submitting mail to grievances.gdcuri@gmail.com or in writing to the Teacher/HOD/ Principal/ any member or the anti ragging committee.
- 2. On receipt of the complaint, the same shall be forwarded to the anti ragging committee within 24 hours for its immediate redressal.
- 3. The committee, as the case may be, shall fix a date for hearing the complaint which shall be communicated with the aggrieved student and conduct enquiries, provides assistance and redressal to the victims.
- 4. The committee shall conduct the proceedings in accordance with the principles of natural justice.
- 5. Minutes of all the proceedings of the committee shall be prepared and duly signed by the members of the committee.
- 6. The committee shall complete its proceedings within a period of 02 weeks from the date of receipt of the complaint.
 - i. Warning and Written Apology.
 - ii. Bond of good behavior.
 - iii. Suspension from attending classes and academic privileges.
 - iv. Debarring from appearing in the examination.
 - v. Debarring from representing the initiation in any regional/national/internationalcultural/sport/NSS/NCC etc activities.
 - vi. Debarring or withdrawing from any scholarship/ fellowship benefits.
 - vii. Adverse remarks in provisional/character certificate and recommendation letter.
 - viii. Rustication from the institution for a specified period depending upon the gravity of offence.
 - ix. Cancellation of admission.
